

MINUTES OF THE TENDER COMMITTEE MEETING (E- TENDER) HELD ON 25/06/2018 AT 4.00 PM IN THE CONFERENCE HALL OF OFFICE OF THE DEPUTY COMMISSIONER, BONGAIGAON FOR SELECTION OF HANDLING AND TRANSPORT CONTRACTOR FOR CARRYING OF FOOD GRAINS (RICE) UNDER NFSA'2013 FOR 2018-2019 IN BONGAIGAON DISTRICT.

**Points Discussed and Decision Taken:-**

This office issued E-Tender Notice for carrying contractor of NFSA Rice as follows:-

- 1) First E-Tender Notice was issued (Through E-Tender Portal) vide this office E-NIT No. BNS.(NFSA).5/2017/Tender/110 Dated 04/04/2018. Single Bid was received and cancelled.
- 2) Second E-Tender Notice was issued (Through E-Tender Portal) vide this office E-NIT No. BNS.(NFSA).5/2017/Tender/120 Dated.08/05/2018. Two Bids were received and only one Bid was found responsive. Price Bid was not opened. Bid was cancelled.
- 3) Third E-Tender Notice was issued (Through E-Tender Portal) vide this office E-NIT No. BNS.(NFSA).5/2017/Tender/211-224 Dated. 04/06/2018. Only Single Bid has been received. It is seen that even after issuing Bid Notice for three times, we could not find responsive Bidders numbering three or more.

The last contract ended on 31/03/2018. The contractor is on extension.


The Committee therefore recommends that since Bidders are not coming even though repeated Bids have been issued, it is prudent to open the Technical Bid of the single Bidder. Thus the Technical Bid is opened. All requirements like turnover, experience etc. are positive or as per Bid condition. Therefore the Technical Bid submitted by Shri Rohit Agarwala, Sulochana Bhawan, Natun Bazar, B.O.C, Gate, North Bongaigaon, Bongaigaon, Assam PIN 783380 is declared responsive. The Committee also recommends to open the Price Bid of the single responsive Bidder.





