5. The rates once quoted shall be final and no alternation or modification of rates shall be allowed after the tender once submitted and consequently approved.
6. The undersigned reserves the rights to reject any or all the quotations in respect of the rates being quoted highest or lowest by the intending quotationers without assigning any reason thereof. The decision of the undersigned in the quotation is final.
7. The sealed cover should be superscribed as "**SHORT QUOTATION FOR SUPPLY OF C.C. T.V. CAMERA**" for the Financial year 2017-2018.

9. After finalization of the tender, the work must be completed within 28/02/18 days from the receipt of work order.


