Sealed tenders are invited from the interested party/firms/individuals affixing non-judicial stamps of Rs. 8.25 (Rupees Eight and twenty five paise) only for supply of show room new Bus/Star bus having seating capacity of at least 25 to 32 seat for carrying Jail inmates at District Jail, **Abhayapuri/Goalpara** under strict supervision of District Jail authority as per terms and condition mentioned below. Necessary payment will be borne by the undersigned subject to allotment of Budget from Inspector General of Prisons, Guwahati as per rate fixed by the Principal Secretary to the Govt. of Assam, Transport Department Notification vide **No.TMV/378/2007/39A Dated 6th February, 2014 (Copy enclosed)**

The rates of hire charges of vehicle and driver and handyman should be written in the tender form distinctly both in figures and words. The sealed quotations can be dropped in the tender box placed in the office of the Deputy Commissioner, Bongaigaon from 23/4/2017 and shall be received till 3 P.M. on **17/05/2017**. The sealed tender box will be opened in the same day on **17/05/2017 at 4 P.M.** in presence of the interested tender or his/her authorized representatives. Details of the specifications of the tenderers can be obtained from the office of the Deputy Commissioner, Bongaigaon in all working days up to **3 P.M. till 17/5/2017**

TERMS AND CONDITIONS

- 1) The rates should be accompanied with an earnest money of **Rs.1000/-**(Rupees one thousand) only in the shape of Govt. Treasury receipt/NSC/Call deposit in favour of the Deputy Commissioner, Bongaigaon. No cash amount will be accepted. The earnest money of unsuccessful tenderer will be returned to the tenderers after observing all formalities.
- 2) The Tenderder shall furnish up to date Income Tax/Vat Tax & Sales Tax clearness certificate along with the tender papers.
- 3) The rates should be written in ink or typed properly and in case of any correction should contain proper initial.
- 4) Rate should be quoted as per Transport department Notification No. TMV/378/2007/39A Dated 6th February, 2014.
- 5) Discipline/Timings and instruction/directions be strictly followed as an when directed by the District administration/Jail authority, **Abhayapuri/Goalpara**
- 6) Any violation of the terms and condition stated therein the undersigned shall have the right to release vehicle without assigning any reason thereof.
- 7) Maintenance of vehicle/Driver/Handyman will be borne by the party from their own capacity
- 8) Bills must be submitted to the undersigned in time and maintained Log sheet & POL accounts from the Jail authority with proper seal and signature(After finalization of tender)
- 9) Hire charge of Vehicle payment with driver & handyman will be paid after receipt of Budget/FOC allocation from I.G. Prisons, Assam time to time (Subject to availability of fund)
- 10) The hire charges of rates as submitted by the tenderer shall be final and no alternation or modification of rates shall be allowed after the tender once submitted and subsequently approved.
- 11) Successful Tenderer must be in a position to give delivery the new show room Bus/Star bus having with seating capacity 25 to 32 seater.
- 12) No old vehicle shall be accepted.
- 13) The undersigned reserves the rights to reject any tenders in respect of rate being quoted by intending tenderer without assigning any reasons thereof.
- 14) There is no provisions for agreement of hired vehicles.
- 15) Necessary POL will be provided as per mileage by the office of the undersigned from time to time.
- 16) Financial sound certificate from Bank must be attached with tender papers.
- 17) The Tenderer must submit attested copies of Pan Card/SBI Account number/Photograph of the owner for transferring billed amount.
- 18) Iron net fully covered the windows, entry & exit point of vehicle as directed by Jail authority Abhayapuri/Goalpara.

No. TMV 378/2007/39 In suppression of all earlier Notifications regarding fixation of rates of hiring and in pursuance of Section 4 of the **Assam Requisition and Control of Vehicle Act' 1968 (Assam Act V of 1969)** the Governor of Assam is pleased to fix the rates of hiring of the different categories of vehicles per diem and daily allowances of driver, conductor and handyman as given below

Daily Allowance - The daily allowance for driver of the vehicles will be Rs. 200 00/- (Rupees two hundred) only and that of conductor/handyman will be Rs. 150 00/- (Rupees one hundred fifty) only. No conductor/handyman shall be allowed for LMV's like Tata- Sumo/ Maruti Van/ Esteem/ Indigo/ Marina/ Qualis/ Travera/ Scorpio/ Innova etc. Vehicle hired for use in other states and not for the parent state are entitled to daily allowance @ of Rs. 250 00/- (Rupees two hundred fifty) only for drivers and Rs. 180 00/- (Rupees one hundred eighty) only for conductors.

The following terms and conditions shall apply in hiring of vehicles for the public purposes mentioned above

1. Under no circumstances a vehicle shall be hired en-route while the passengers are on board.
2. While hiring of vehicles, as far as practicable, vehicles from other States should not be hired. If however such vehicles are hired they shall be entitled for payment as per hiring rates applicable in their States.
3. When a vehicle is hired repairing charge is to be borne by the owner. Therefore, while hiring a vehicle, the hiring authority should ensure that the vehicle is properly insured, so that the owner can claim damages from Insurance Companies in case of accidents etc.

The rates will be effective from the date of Notification.


