Sub: Questionnaire relating to the Sixth Assam State Finance Commission.

Sir,

The Sixth Assam State Finance Commission has been constituted by the Government of Assam vide Notification No. FEA (SFC) 179/2017/74 Dated 09/11/2018 headed by Smti. T.Y.Das, IAS (Retd.), former Chief Secretary, Assam.

As per the provision of Articles 243-I and 243-Y of the Constitution, the Commission is mandated to make recommendations as to the following:-

- v) The principles of distribution between the State of Assam and the Panchayats and Municipalities of the net proceeds of the taxes and duties levied and collected by the Government of Assam;
- vi) the determination of the taxes, duties, tolls and fees, which may be assigned to, or appropriated by the Panchayats and Municipalities;
- vii) the grants-in-aid to the Panchayats/Municipalities from the Consolidated Fund of the State;
- viii) The measures needed to improve the financial position of the Panchayats and Municipalities with special references to :-

In accordance with terms of reference (ToR) given to the Commission, among other things, it is also required to make a review of the receipts and expenditure of the Local Bodies as a whole and each local body separately. In order to make an assessment of the financial position of the PRIs and ULBs at all levels, the Commission will require a lot of information and data each local body-wise. The details of such information and data ~~are~~ to be incorporated in a questionnaire framed separately for the Panchayats and Municipalities.

**A portion of the questionnaire PART III relating to ANNUAL ACCOUNTS of ULBs is appended here with for submission of a consolidated report after obtaining necessary inputs from your concerned district offices.**

You are therefore, requested kindly to ensure that replies to the questionnaire complete in all respect reach SFC Cell of Finance (Economic Affairs) Department **on or before 15<sup>th</sup> February, 2019.**
